



## “HANFORD BRANCH WEEKEND GETAWAY– \$1,500 GIVEAWAY “ SWEEPSTAKES OFFICIAL RULES

### **No Purchase Necessary to Enter or Win.**

**Odds of winning are based on number of entries received. Each Sweepstakes entry will have an equal chance of being drawn.**

**ENTRY PROCEDURES:** Automatically receive one Sweepstakes entry for each transaction made, five entries for each loan booked, and ten entries for each basic HAPO Savings account opened at the HAPO Hanford Financial Center located at 2952 George Washington Way, Richland, between 09:00:01AM Pacific Standard Time (PST) January 8, 2010 and 05:29:59PM PST February 26, 2010 (“Promotion Period”). Additional entries may be awarded for specific requirements as determined during contest. Transactions through the mail, over the phone, or made online are not considered eligible transactions for Sweepstakes entry. Transactions must be conducted at the HAPO Financial Center located at 2952 George Washington Way, Richland, WA 99354 to be considered for eligibility.

**NO PURCHASE NECESSARY TO ENTER:** You do not have to be a HAPO member to enter. To enter the Sweepstakes hand print on a plain piece of 3” x 5” paper, your complete name, street address (P.O. Box), city, state, zip code, date of birth, daytime and evening telephone numbers, and e-mail address. All entries must have a contact telephone number. Mail your entry in a hand addressed business-size (#10) envelope with first-class postage affixed, to: “Hanford Branch Weekend Getaway” Sweepstakes, 601 Williams Blvd. Richland, WA 99354. All entries must be received by February 26, 2010 by 5:30 p.m. Pacific Standard Time (PST). Limit one mail entry per person. Limit one entry per envelope. No mechanically reproduced entries permitted. Illegible/incomplete entries are void. The Credit Union is not responsible for lost, late, mutilated, postage due, misdirected entries or entries not received in time for the random drawing. If an entry form is drawn but judges are unable to determine the Winner because of illegible writing, or if the entry form is incomplete, that entry form will be disqualified. Proof of mailing does not constitute proof of delivery. Once submitted, entries become the sole property of the Credit Union and will not be acknowledged or returned. Failure to comply with this or any other official rule will result in disqualification.

**ELIGIBILITY:** HAPO Community Credit Union’s “Hanford Branch Weekend Getaway” is open to any individual who is 18 years of age or older and a legal U.S. citizen. Officers, directors, volunteers, and employees of HAPO and members of their immediate families (spouse, parent, child, and sibling) and persons residing in their households are ineligible to enter the Sweepstakes or win a prize. If the Winner does not respond to our notification within seven (7) days from the first notification attempt, then such person shall be disqualified and an alternate Winner will be selected.

**PRIZE:** The Winner will be awarded a \$200 VISA gift card, and a \$1,300 gift card to The Coeur d’Alene Resort in Coeur d’Alene, Idaho.
